

General terms and conditions for hiring function rooms

1. Hire

Function room bookings will become legally binding as soon as the booking has been confirmed in writing by the Restaurant LUEGETEN.

2. Settlement of the bill

The full amount of the Restaurant LUEGETEN bill is to be paid within 10 days of the invoice date. The Restaurant LUEGETEN is entitled to request instalments in advance. The VAT of 8.0% are in all prices included

3. Numbers attending

The Restaurant LUEGETEN is to be notified of the final number of persons attending (guaranteed number) at the latest 24 hours before the event by the event organiser.

If the number of persons attending is further reduced before 9.00 am on the day of the event, 20% of the amount due for the services booked shall be charged for the persons who have cancelled. If there is another change during the event itself then the Restaurant LUEGETEN will invoice for the guaranteed number.

4. Cancellation

A) Should the event organiser call off the event before the event date then the Restaurant LUEGETEN reserves the right to request a payment for the room hire, and the amount of which shall depend on when the booking was cancelled:

- ✓ up to 40 days before the event date: no rental payment shall be required
- ✓ 39 to 30 days: payment of 30% of the charge for the services booked or the minimum charge
- ✓ 29 to 14 days: payment of 45% of the charge for the services booked or the minimum charge
- ✓ 14 to 0 days: payment of 60% of the charge for the services booked or the minimum charge

The bill shall be calculated as follows: the services booked x expected number of persons attending.

In the event that it is possible to hire the rooms booked to another party the above charge shall not be payable.

Bookings for special services such as decorations and entertainment etc. which are no longer required due to the cancellation shall be payable without exception.

B) Should the Restaurant LUEGETEN have reason to suspect that the event may threaten the smooth running of the business, the security or the reputation of the Restaurant LUEGETEN then the Restaurant LUEGETEN is entitled to cancel the event without being liable to pay compensation.

5. Late night surcharge

For events continuing later than 0.00 am a late night surcharge of CHF 200.00 till 02.00 am, between 02.00 am till 04.00 am ist the surcharge CHF 300.00 for each hour or part there of shall be billed.

6. Damages

A) The event organiser shall be responsible for insuring any display items that have been brought on to the premises. The Restaurant LUEGETEN cannot accept any responsibility for any items which go missing or which are damaged.

B) The lessee shall be liable for any damage to, or heavy soiling of, the rooms, furnishings and technological aids.

7. Food and drink

Food and drink are to be purchased from the Restaurant LUEGETEN. In special circumstances (national specialities etc.) and upon payment of a service charge or of a corking charge other arrangements may be made and agreed in writing.

8. Insurance

The Restaurant LUEGETEN will not accept any liability for the theft of, or damage to, objects, clothing or materials which have been brought onto the premises.

9. Legislation/court of jurisdiction

The general terms and conditions and any additional agreements as well as the contract concluded on the basis of said documents shall be governed exclusively by Swiss law. The Höfe District Court in Wollerau in Canton Schwyz shall have the exclusive jurisdiction to settle any disputes.

10. Amendments

Amendments to these general terms and conditions must be made in writing.
